WHEREAS, the Capital Budget as adopted reflects Total Capital Appropriations of \$1,300,000 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$1,300,000; and

WHEREAS, the Capital Budget as amended on March 23, 2021 reflects Total Capital Appropriations of \$6,300,000 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$6,300,000; and


WHEREAS, the Capital Budget as now amended reflects Total Capital Appropriations of \$6,300,000 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$6,300,000,


